



# ***GRC Bulletin* Editorial Policies and Guidelines for Authors**

The Geothermal Resources Council (GRC) *Bulletin* is a periodic publication (6 issues per year) that reaches the association's worldwide membership and paid subscribers. Current circulation is 1,500. The *GRC Bulletin* provides a technology and issues forum for professionals involved in geothermal resource research, exploration, development and utilization. The *GRC Bulletin* also provides news and information that highlights the environmental and economic benefits of geothermal resource development.


The GRC seeks well-written, positive and interesting features for the *Bulletin* from qualified professionals throughout the international geothermal community. Submissions of abstracts, research papers, topical articles, commentaries and editorials on all aspects of geothermal resource research, exploration, development and utilization are encouraged. *The GRC also accepts paid advertisements—please call for prices and contract information.*

Though highly specific technical papers are occasionally published in the *Bulletin*, the GRC prefers submissions of a more general nature that feature new information on techniques, processes and technologies. Articles should offer the GRC's diverse readership pertinent, up-to-date information and data on geothermal resources and development, while providing viewpoints on implications for the industry (and society, if applicable). The GRC also welcomes press releases and announcements from government organizations, companies and individuals that provide information on recent developments and interesting accomplishments related to geothermal energy resources and development. Calendar notices of geothermal and renewable energy events are always accepted.

## ***Bulletin* Editorial Policy**

The mission of the *GRC Bulletin* is to publish and distribute timely, useful data and information on geothermal resources that supports domestic and international development. The GRC wishes to provide a forum in the *Bulletin* for exchange of factual, pertinent information. Though the *GRC Bulletin* is not a rigorously peer-reviewed research journal, all materials submitted for publication are subject to content and quality review by the GRC Executive Director, the Managing Editor, and selected professionals from the geothermal community. ***The GRC will not publish any material that is negative, aggressive, accusatory or provocative in tone, or has the potential to damage the geothermal development industry or any company's ability to carry out its legal business interests.***

Authors are responsible for ensuring the veracity of the materials they submit. The GRC will not print information based on conjecture, that cannot be verified, or which contains confidential or privileged information. Materials submitted for publication must not comment on specific individuals or companies without their knowledge or permission. *The GRC reserves the right to edit all submissions for the Bulletin, and reject any materials it deems unsuitable for publication. Articles, commentaries, editorials and other information accepted for publication in the Bulletin do not necessarily reflect the policy or opinions of the GRC or its members.*



## **Bulletin Submission Guidelines**

**Length.** Submissions should be no longer than 3,000 words.

**Text.** Text for articles and other submissions should be submitted by email, or mailed to the GRC in printed form (hard copy) accompanied by either disk or CD. Text files can be saved in either Microsoft Word or Word Perfect.

**Graphs, Illustrations and Tables.** Graphs, illustrations and tables must be pertinent to the article and professionally drafted. Send sharp, camera-ready hard copy (in black-and-white only) of graphs, tables and illustrations with electronic files submitted on disk or by e-mail. ***Disk or CD files of figures must be submitted in TIF or EPS formats from the original drawing program. Do not save graphs, illustrations and tables as Microsoft Word files. Because of quality and conversion problems, PowerPoint figures cannot be accepted for publication.***

**Photographs.** Well-composed, sharp photographs are a plus for any article if pertinent and accompanied by complete descriptive captions. Photographs of people interacting or working in the context of the article are encouraged. Submissions may be slides or prints in color or black-and-white. ***Quality considerations for digital photographs are paramount—they must be submitted as JPEG files sized from 4"x6" to 8"x10" at a resolution of 300 dpi.*** If requested, photographs will be returned on completion of publication, otherwise they will be retained by the GRC. Submission specifies the GRC's right to retain copies for potential future use.

**References.** Proper style in listing references is important to the veracity of the *GRC Bulletin* and the needs of our readership. References should be provided as an alphabetical list (by lead author surname) at the end of submitted articles, and be arranged by author(s) (surname followed by initials), year, title, journal, volume number, and page numbers. References within text should be cited by author(s) surname and year of publication. ***Please use proper punctuation in all references.***

**Deadlines.** Unless authors have made other arrangements with the GRC, articles and other materials accepted for publication will appear in the next appropriate issue of the *Bulletin*. Please call the Managing Editor to discuss your ideas and submissions, deadlines and potential publication dates.

**Copyright.** If a submission has been previously published and copyrighted, authors must inform the GRC and provide a copyright release from the publisher.

**Payment.** The GRC accepts for review all articles freely offered by qualified authors. The GRC typically does not provide payment for *Bulletin* article submissions.
