## **IMPORTANT: MEMBER CONSENT TO USE OF ELECTRONIC TRANSMISSIONS FOR ELECTIONS, BALLOTS, AND OTHER COMMUNICATIONS WITH GRC**

As a member of Geothermal Resources Council (the "GRC"), you must provide written consent in order to receive official communications from, and send official communications to, the GRC via electronic transmission. Before you sign this consent form, please review the following:

- You are encouraged but not required to sign this form. If you do not sign, the GRC will mail official communications to you at your mailing address of record.
- This consent to electronic transmission applies to all official communications from the GRC, including but not limited to elections, ballots, meeting notices, and special reports.
- To consent, you must mail or fax your signed consent to the GRC at the address or fax number listed below.
- You have the right to withdraw this consent at any time by mailing or faxing a notice of revocation to the GRC at the address or fax number listed below.

You must ensure that you have access to each type of electronic transmission you accept, which includes ensuring that the electronic transmission will not be blocked or redirected by your security protocols and filters. If a communication to the fax or email address below is returned, GRC will mail a request for updated information from the member. As is also true for mail addresses, if a member does not keep GRC apprised of up-to-date contact information, GRC cannot guarantee that you will receive communications timely.

Having reviewed the foregoing, I agree to the following:

1. The GRC may send official communications to me using the form(s) of electronic transmission indicated below.
2. The GRC may rely on communications sent by me to the GRC via electronic transmission that matches the contact information listed below. The GRC may reasonably conclude that I am the author of those communications.
3. The GRC may rely on any ballot that I submit to GRC by electronic transmission as an accurate and valid vote cast by myself as a GRC member under the Bylaws of the GRC, provided such ballot is electronically transmitted by me to GRC within the time parameters established by the GRC board for such vote. This consent shall remain in full force and effect until the GRC receives a revocation from me, as set forth above.

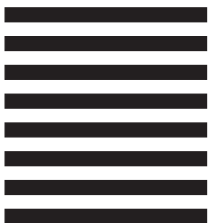
